

Community Assessment

1. Define & Engage the Community

Build Coalition Capacity

1. Build Coalition Membership

- Support

Case Study – The Maui Social Host Ordinance Campaign

The Background...

- First policy campaign from start-to-finish
- First local social host ordinance for Hawai'i
- Took about 3 years from assessment to passage

Initial Engagement: Person vs. Position

- Intentional ID of sector member
 - Who finds this work interesting?
 - Best to have someone who has access to decision makers, but generally advise against law makers as members (mayors, council, commissions)
 - If law makers engaged, have a process to ensure shared decision-making within the coalition
- One-on-one meetings to build rapport
- Introducing the coalition's role and public health approach to prevention at onset and revisit the topic often
- Build consensus of person's sector role
- Obtain supervisor permission for participation
- Recruit to specific tasks, not meetings

SPF Step 1: Assessment Phase

A compelling case for our local condition of house parties

- 400+ youth surveys - Over 50% of UAD at house parties
- 100+ adult surveys - Over 90% of parents don't want their child drinking at someone else's house
- Dozens of interviews and listening sessions - youth, adult, and law enforcement

Government Engagement in Assessment

- ✓ Connected coalition to key informants in the community
- ✓ Law enforcement, parks dept., youth-serving orgs, liquor commission, county council, schools
- ✓ Provided archival data
- ✓ Participated in youth listening sessions to connect them to the process *and* the problem of youth substance use

The Coalition's Training Plan

Training plan focused on building policy-readiness

- ✓ Training on a public health approach to prevention
- ✓ Education vs. lobbying
- ✓ Clarify who can/is willing to lobby
- ✓ Training on policy options
- ✓ Leadership training
- ✓ Community organizing training
- ✓ Media advocacy training
- ✓ Coalition organization training

Government Sector Engagement in Capacity Building

- Connected the Coalition to Youth Centers & Schools to develop PSAs
- Provided training funds to shift coalition work toward policy development
- Key gov't leaders attended local & national conferences
- Developed organizational partnerships to support the policy (law enforcement, community orgs)
- Authored media stories & LTEs

SPF Step 3: Planning

Importance of Planning

1. Informed coalition of policy options
2. Obtained consensus and commitment to pass a SHO
3. Created a policy action statement
4. Developed an action plan

- Provided space & funding for meetings & trainings
- Met one-on-one to answer questions & any hesitation on the policy
- Onboarded organizational partners
- Connected coalition to key gov't departments & commissions

Implementation of the Social Host Ordinance

- Key Elements for the SHO:
 - Created an issue brief
 - Met with town council
 - Drafted policy language
 - Organized support
 - Leveraged the media
 - Passed the policy

Government Sector - Implementation

- Participated in ad hoc issue brief workgroup
- Integral in drafting the policy language – ensured language aligned with current systems
- Met with key council members & mayor to garner support
- Authored LTEs & connected coalition to local radio & newspaper
- Testified in support of the measure

SPF Step 5: Evaluation

Key Elements

- Confirmed our baseline data
- Created systems for law enforcement data collection
- Developed a data collection & evaluation plan
- Will share evaluation data with our community

Gov't Sector Involvement in Evaluation

- ❖ Connected the coalition with the police department's data analyst to develop the data collection system
- ❖ Currently developing new internal processes to assess and evaluate prevention services
- ❖ Leveraged their relationships with key partners who can assist in collecting data on SHO
- ❖ Will use evaluation findings to inform their funding & prioritize future needs

Cultural Competence

Key Elements for the Social Host Ordinance

- Commitment to ensuring equity in the policy
 - Got community input on fine structure
 - Included a community service option
 - Created an appeals process
 - Demographic data collection to ID any disparities, harms
- Created culturally relevant messaging
- Recruited members that represented the culture and diversity in the community
- Developed leadership of individuals representative of populations of focus (youth, parents, Native Hawaiians, etc.)

Gov't Sector Involvement in Cultural Competence

- Provided funding for youth training & engagement – CADCA training & ongoing youth development coaching
- Connected the coalition to youth groups such as SADD, Key Clubs, school media club
- Connected the coalition to cultural & community groups
- Provided feedback on policy language to reduce unintended harms and potential pitfalls related to the gov't administration of the law

Gov't Sector Support - Sustainability for the Social Host & Beyond

- Wrote an evaluation component into the law
- Changed practices within the gov't division to ensure community-level prevention included in prevention system
- Leveraged local funding to support coalition activities
- Dedicated staff time to increase prevention services
- Provided free meeting space
- Created opportunities for leaders to show support for the coalition (proclamations, media pieces)

Tips for Engaging Local Government

- Know your government structure
- Know who is important and what is important to them
- Build relationship with permanent staff
- Take the advice given
- Have integrity and follow through on your commitments
- Find and cultivate champions who will leverage their power to influence others

Possible Pitfalls to Avoid

- Don't assume support or assume that your coalition's initiative is a priority for them
- Use the system that's in place
- Stay on the "good side" of the funder
- Plan ahead and expect delays - the gov't does not move fast, and it's no one person's fault
- No talk stink about nobody! You could lose access to key gov't partnerships for years
